Preferences: Families who qualify for the higher **PREFERENCE** points will go to the top of the Wait List and be housed first. A maximum of 5 points is available if a family qualifies for all preferences. **Preferences WILL BE VERIFIED!** A family may have no preferences and still remain on the Wait List, but will be housed after all of the families who do have preferences. If your preference changes, please complete this form and return it to HAMC.
